1. INTRODUCTION

The Foreign Trade Statistics Report is produced by the Balance of Payments Unit of the Economics and Statistics Office (ESO). The statistics on imports are primarily obtained from the computerized records of the Customs Department as maintained by the Computer Services Department as well as from data generated from the new Total Revenue Integrated Processing System (TRIPS). These records are based on documents on the importation and exportation of goods as completed by importers, exporters or their agents who are required to record the appropriate statistical tariff code using the Cayman Islands Customs Tariff Law (CICTL). The CICTL is based on the Harmonised System (Harmonised Commodity Description and Coding System) of the Customs Cooperation Council (CCC).

The task of the ESO is mainly to incorporate and check the credibility of the data, and classify them into tables that can be useful for analysis. The process of classification is a timeintensive, laborious task as there have been a significant number of goods that are not classified or mis-classified. The objective of the classification process has been to minimize the number of such cases; over the years, the value of commodities that are not classified by SITC codes has diminished.

In addition to the classification by SITC codes, ESO also classifies all imported commodities by Broad Economic Category (BEC) based on international guidelines issued by the United Nations (UN).

ESO compiles exports data mainly from external sources namely, the US Census Bureau, the Statistical Institute of Jamaica and the UK Trade Data Online website. Exports data taken from the Customs Department are used to complement these.



2. EXPLANATORY NOTES AND DEFINITIONS

2.1 Trade Classification Systems

The Cayman Islands' version of the Harmonized System of Classification is the primary classification standard used for the Cayman Islands' foreign trade. In addition, the Standard International Trade Classification (SITC) Rev 3, which is the classification of international trade issued by the United Nations (UN), is used for the compilation of both the imports and exports of goods. Finally, the classification of imports by Broad Economic Categories (BEC) is based on international standards recommended by the UN.

2.2 System of Trade

The "General Trade System" is the system of coverage used in the tabulation of merchandise in this report. Under this system, all goods entering the Cayman Islands are recorded as imports while all goods leaving the country are recorded as exports.

2.3 Coverage

This report covers merchandise trade only. Trade in services are not included.

Included in the import and export statistics in this publication are goods sent abroad for repair and returned and goods re-exported as incorrect or faulty since they cannot be easily identified at the time of import. Excluded are goods in transit or other trans-shipments not destined for the Cayman Islands market, monetary gold and bullion, bank notes and coins in circulation; and parcel post exports for which no records are kept. Goods brought into the country directly by residents but are not declared are also excluded by default for lack of documentation.

The values recorded for imports and exports over a particular period represent the documents brought to account by Customs during that period. They may also include some goods actually arriving towards the end of the previous period but are accounted for in the current period.

Exports statistics cover both re-exports and domestic exports. Re-exports, which comprise the larger part of exports, are goods of foreign origin which have not been materially transformed while in the Cayman Islands. Domestic exports include goods produced in the country, extracted from its natural resources or manufactured in the country. These include goods of foreign origin which have been assembled or transformed in the country.



2.4 Valuation

All values are shown in Cayman Islands dollars (CI\$). Imports are valued at cost, insurance and freight (c.i.f) which is the value up to the time of delivery at the port. It includes incidental charges but excludes customs or any other duty paid on arrival.

Exports are valued at free on board (f.o.b), that is the value at which goods were sold by the exporters, and it includes all local charges to the exporting vessel or aircrafts. Freight and insurance are not included.

2.5 Revisions

Revisions are inevitable, thus the trade data have been revised largely as a consequence of corrections on previous errors, omissions, and misclassifications as reflected in the updated entries of the Customs computer system.

2.7 Limitations

In the Cayman Islands, a number of importers do not provide codes, or provide improper codes. Over the years, this issue required the ESO to vigilantly verify codes and provide missing ones. ESO continues to review the imports data with the aim of improving the accuracy, reliability and proper classification of the data.

Given the volume of imports, full details of the quantity and value of all imports are not available. A new Cayman Islands Customs tariff and data collection system went into effect on March 1, 2013, and will hopefully address many of the issues encountered with the previous system.



3. COMMENTARY ON TRADE 2013

3.1 Visible trade balance

In 2013, the balance of visible trade was in deficit amounting to CI\$749.1 million. This resulted from total imports of CI\$774.5 million which overwhelmingly outweighed exports (CI\$25.3 million) (see Table 1.1).

The visible trade deficit in 2013 was higher compared to the CI\$741.6 million recorded in 2012 as the increase in the total value of imports (CI\$16.0 million) exceeded the rise in exports (CI\$8.4 million) (see Table 1.2 and Chart 1).




Chart 1: Visible Trade Balance, 2012 and 2013



3.2 Imports

In 2013, the total value of all goods imported rose 2.1 percent to reach CI\$774.5¹ million, compared to CI\$758.5 million recorded in 2012 (see Tables 2.1 to 2.7). The increase is due to petroleum products which rose by 10.5 percent to CI\$167.8 million. The total value of non-petroleum imports was CI\$606.6 million, which is not significantly different from the 2012 value.

As in prior years, mineral fuels, lubricants and related materials accounted for the highest share of all imports (22.1%) followed by food and live animals, miscellaneous manufactured articles and machinery and transport equipment. These four groups together accounted for 70.7 percent of all imports.




Chart 2: Percentage Distribution of Imports by SITC Section, 2013

Imports by category of goods

Chiefly influencing the performance of imports in 2013 was the rise in mineral fuels, lubricants and related materials from CI\$155.1 million in 2012 to CI\$170.9 million. This is traced mainly to an increase in the quantity of motor gas, coupled with an increase in the average prices of motor gas, diesel and aviation fuel.

Increases were also recorded for the following categories:

- Food and live animals rose 8.3 percent largely reflecting increases in the value of fish and fish preparations; meat and meat preparations; feeding stuff for animals; miscellaneous edible products and preparations; and vegetables and fruits. On the other hand, live animals (except fish) fell 16.9 percent.
- Beverages and tobacco recorded an increase of 3.4 percent with beverages increasing by 5.3 percent to a value of CI\$26.6 million. In contrast, tobacco products decreased by 9.8 percent to CI\$3.4 million.
- Chemical and related products category saw an increase of 4.2 percent, largely on account of plastics in primary form (63.9%), inorganic chemicals (9.3%), dyeing, tanning and colouring materials (8.9%) and medicinal and pharmaceutical products (5.7%), while other items declined such as chemicals (-10.6%) and essential oils, perfume and toiletry products (-5.3%).
- Manufactured goods classified chiefly by materials showed an increase of 1.8 percent. Accounting for this movement was a rise in non-ferrous metals (48.8%); leather manufactures (44.6%); iron and steel products (37.8%); paper and paper products (17.0%); and non-metal mineral manufactures (4.8%). However, declines were posted for textile yarn, fabrics and related materials (-4.9%), rubber manufactures n.e.s (-10.5%) and cork and wood manufactures excluding furniture (-6.7%).
- Machinery and transport equipment grew slightly by 1.0 percent, following the increases in telecommunications equipment (26.3%), general industrial machinery and equipment (9.1%) and electrical machinery and apparatus (5.2%). However, power generating machinery and equipment, office machinery, road vehicles, and specialized machinery fell.



The major groups that moved downwards in 2013 compared to 2012 were:

- Miscellaneous manufactured articles which fell by 7.7 percent. This category includes footwear and miscellaneous manufactured articles, n.e.s.
- Commodities and transactions not classified elsewhere saw an 11.2 percent decrease, as sharp declines were recorded for gold, non-monetary (excluding gold ores and concentrates), and postal packages.

Imports by country of origin

The USA continues to be the dominant trading partner of the Cayman Islands accounting for 92.3 percent of total imports with a value of CI\$714.0 million in 2013, an increase compared to the CI\$678.0 million in 2012. However, imports from Jamaica fell by 17.6 percent, and from the UK by 47.9 percent. Additionally, imports from Cuba fell by 54.9 percent reflecting the decline in cigar imports, while imports from Japan dropped 44.2 percent, reflecting the fall in the importation of vehicles. Imports from all other countries also decreased in 2013 when compared to 2012.

Imports by broad economic category

An analysis of imports by broad economic classification (BEC) reveals that capital goods rose 9.0 percent, reflecting the continued rise in construction activity in 2013. Growth of industrial supplies was recorded at 6.6 percent. Fuels and lubricants and food and beverages also rose 10.2 percent and 7.7 percent respectively. In contrast, consumer goods other than food and beverages dipped by 15.8 percent (see Table 2.7).

3.3 Exports

In 2013, total exports grew 49.2 percent to CI\$25.3 million compared to the CI\$17.0 million in 2012. Sharp increases were recorded for food and live animals (26.9%), animal and vegetable oils (75.0%), and commodities and transactions not elsewhere specified (95.6%) (see Table 3.1). All other categories decreased from the 2012 levels.

The majority of exports (89.9%) comprised of commodities and transactions not elsewhere classified, which are mostly re-exports of personal effects, and the return of of aviation equipment and parts which were imported in previous periods.
