#### 1. INTRODUCTION

The annual Foreign Trade Statistics Report is produced by the Balance of Payments Unit of the Economics and Statistics Office (ESO). The statistics on imports are primarily obtained from the computerized records of the Customs Department as maintained by the Computer Services Department as well as from data generated from the Total Revenue Integrated Processing System (TRIPS). These records are based on documents of imports and exports of goods as completed by importers, exporters or their agents who are required to record the appropriate statistical tariff code using the Cayman Islands Customs Tariff Law (CICTL). The CICTL is based on the Harmonised System (Harmonised Commodity Description and Coding System) of the Customs Cooperation Council (CCC).

The task of the ESO is mainly to classify the Customs data using the Standard International Trade Classification (SITC) Revision 3, incorporate data from other relevant sources such as the Port Authority and the Petroleum Inspectorate, and present the data in aggregate format. The process of classification by SITC is a time-intensive, laborious task as there have been a significant number of goods that are not classified or misclassified. The objective of the classification process at ESO has been to minimize the number of such cases; over the years, the value of commodities that are not classified by SITC codes has diminished.

In addition to the classification by SITC codes, ESO also classifies all imported commodities by Broad Economic Category (BEC) based on international guidelines issued by the United Nations Statistical Division (UNSD).

ESO compiles exports data mainly from external sources namely, the US Census Bureau, the Statistical Institute of Jamaica and the UK Trade Data Online website. Exports data taken from the Customs Department are used to complement these.



#### 2. EXPLANATORY NOTES AND DEFINITIONS

## 2.1 Trade Classification Systems

The Cayman Islands' version of the Harmonized System of Classification is the primary classification standard used for the Cayman Islands' foreign trade. In addition, the Standard International Trade Classification (SITC) Rev 3, which is the classification of international trade issued by the United Nations Statistical Division (UNSD), is used for the compilation of both the imports and exports of goods. Finally, the classification of imports by Broad Economic Categories (BEC) is also based on international standards recommended by the UNSD.

#### 2.2 System of Trade

The "General Trade System" is the system of coverage used in the tabulation of merchandise in this report. Under this system, all goods entering the Cayman Islands are recorded as imports while all goods leaving the country are recorded as exports.

#### 2.3 Coverage

This report covers merchandise trade only. Trade in services are not included.

Included in the import and export statistics in this publication are goods sent abroad for repair and returned and goods re-exported as incorrect or faulty since they cannot be easily identified as such at the time of importation. Excluded are goods in transit or other transshipments not destined for the Cayman Islands market, bank notes and coins in circulation; and parcel post exports. Goods brought into the country directly by residents but are not declared are also excluded by default for lack of documentation.

The values recorded for imports and exports over a particular period represent the documents brought to account by Customs during that period. They may also include some goods actually arriving towards the end of the previous period but are accounted for in the current period.

Exports statistics cover both re-exports and domestic exports. Re-exports, which comprise the larger part of exports, are goods of foreign origin which have not been materially transformed while in the Cayman Islands. Domestic exports include goods produced in the country, extracted from its natural resources or manufactured in the country. These include goods of foreign origin which have been assembled or transformed in the country.



#### 2.4 Valuation

All values are shown in Cayman Islands dollars (CI\$). Imports are valued at cost, insurance and freight (c.i.f) which is the value up to the time of delivery at the port. It includes incidental charges but excludes customs or any other duty paid on arrival.

Exports are valued at free on board (f.o.b), that is the value at which goods were sold by the exporters, and it includes all local charges to the exporting vessel or aircrafts. Freight and insurance are not included.

#### 2.5 Revisions

Revisions are inevitable, thus the trade data on prior years have been revised largely as a consequence of corrections on previous errors, omissions, and misclassifications as reflected in the updated entries of the Customs computer system.

#### 2.7 Limitations

In the Cayman Islands, a number of importers do not provide codes, or provide improper codes. Over the years, this issue required the ESO to vigilantly verify codes and provide missing ones. ESO continues to review the imports data with the aim of improving the accuracy, reliability and proper classification of the data.

Given the volume of imports, full details of the quantity and value of all imports are not available. The new Cayman Islands Customs data collection system (TRIPS) and the new Customs Tariff 2012 which went into effect on March 1, 2013, have addressed some of the issues encountered with the previous system.



#### 3. COMMENTARY ON TRADE 2016

#### 3.1 Visible trade balance

In 2016, the visible trade deficit increased by \$31.8 million, moving from a deficit of CI\$748.7 million in 2015, to CI\$780.6 million. This resulted from a 2.8 percent increase in the importation of goods along with a 10.4 percent decline in exports. The rise in imports was driven by the increase in machinery and transport equipment imports, while the increased re-export of machinery and transport equipment drove the value of exports (see Chart 1).

The largest contributors to the trade deficit were: (a) food and live animals (CI\$170.0 million); (b) machinery and transport equipment (CI\$169.7 million); (c) miscellaneous manufactured articles (CI\$115.1 million); and (d) mineral fuels, lubricants and related materials (CI\$85.4 million) (see Table 1.1).

## 3.2 Imports


In 2016, the total value of goods imported into the Cayman Islands grew by 2.8 percent to reach CI\$854.2 million, compared to CI\$830.9 million recorded in 2015 (see Tables 2.1 to 2.7). This was largely driven by the increase in the value of non-petroleum imports which outweighed the drop in the value of petroleum imports (mineral fuels, lubricants and related materials).

Non-petroleum products increased by 5.1 percent to CI\$768.8 million compared to the CI\$731.2 million recorded in 2015. Largely accounting for this performance was the increase in the imports of machinery and transport equipment (16.5%).

Petroleum products (mineral fuels, lubricants and related materials) fell by 14.3 percent, due primarily to the continued decline in the international price of fuel, which together with a decline in the total quantity led to the overall decline in the value of petroleum imports. This sustained the downward contribution of fuel imports to total imports, moving from 20.1 percent in 2014, to 12.0 percent in 2015 and further to 10.0 percent in 2016. (See Chart 2).

Machinery and transportation imports which grew by 16.5 percent accounted for 20.1 percent of total imports in 2016 compared to 17.7 percent in 2015. Miscellaneous manufactured articles grew by 2.2 percent and recorded 13.7 percent of all imports similar

to the share in 2015. Commodities and transaction not classified elsewhere dropped by 5.9 percent mainly due to gold imports; its share to total imports thus fell to 14.2 percent from the 15.5 percent recorded in 2015.

## Imports by category of goods

Primarily propelling the increased value of imports in 2016 was a sharp surge in **machinery and transport equipment** which went up by 16.5 percent to reach CI\$171.5 million in 2016, up from the CI\$147.1 million recorded in 2015. This was largely due to the higher value of imports for road vehicles, general industrial machinery and equipment, and office machines and automatic data processing machines. (see Table 2.4). However, telecommunications and sound recording and reproducing apparatus and equipment, electrical machinery, apparatus and appliances and parts thereof and power generating machinery and equipment imports fell.

The value of road vehicles imports increased significantly by 43.0 percent to CI\$71.8 million, largely reflecting the increase in motor vehicles. Additionally, the value of machinery specialized for particular industries, such as construction and mining machinery imports increased from CI\$2.6 million to CI\$5.2 million, while office machines and automatic data equipment rose by 31.2 percent to CI\$8.8 million (see Table 2.4).

The **crude**, **inedible materials**, **except fuels** category grew by 17.3 percent to CI\$14.6 million. This was on account of the increases in imports of crude fertilizers and minerals (24.5%), cork and wood (8.9%) and crude animal and vegetable materials n.e.c (13.5%).

Imports of **beverages and tobacco** grew by 11.1 percent to CI\$34.4 million. Tobacco and manufactures increased by 27.1 percent to CI\$4.3 million in 2016 with cigarettes increasing by 26.3 percent to CI\$3.0 million while cigars grew by 28.8 percent to reach CI\$1.4 million. For the same period, the imports of beverages rose by 9.2 percent to CI\$30.1 million, with alcoholic beverages such as beers and champagne increasing by 13.8 percent to reach a total of CI\$21.9 million compared to CI\$19.3 million recorded in 2015. In contrast, the total value of non-alcoholic beverages including water fell slightly by 1.6 percent moving from CI\$8.3 million in 2015 to CI\$8.1 million recorded in 2016.

In 2016, imports of **chemical and related products n.e s** rose by 10.8 percent and stood at CI\$43.5 million up from the CI\$39.3 million recorded in 2015. This was driven by the increase in imports of paints and varnishes by 25.2 percent to reach CI\$7.2 million compared to CI\$5.7 million recorded in 2015. Additionally, imports of essential oils and perfume materials, toilet polishing and cleansing preparations grew by 10.1 percent largely on account of the increase in soap and washing preparations and cleansers.



Plastics in primary and semi-processed form, largely PVC tubing, saw an increase. On the other hand, medicinal and pharmaceutical products imports fell.

In 2016, the value of food **and live animals** continued on the upward trend increasing by 2.5 percent, to reach CI\$170.5 million. Specifically, growth was recorded for cereal and cereal preparations (39.2%), vegetables and fruits (5.9%), fish and fish preparations (2.7%), and animal feed stuff (4.4%). On the other hand, dairy products and eggs fell by 6.0 percent while meat and meat preparations and sugar and sugar preparations were reduced by 9.9 and 6.9 percent respectively.

The total value of imports of manufactured goods classified chiefly by materials moved up 5.0 percent to reach CI\$95.2 million in 2016 compared to CI\$90.7 million recorded in 2015. Accounting for this performance was the increase in leather and leather manufactures n.e.s and manufactures of metal n.e.s which increased by 26.5 percent and 24.5 percent respectively. In addition, non-metal mineral manufactures n.e.s increased by 1.7 percent to CI\$25.9 million, largely reflecting the higher imports of cement and sanitary and plumbing fixtures. Specifically, the increased imports of manufactures of metal n.e.s were largely in structures and products (parts of iron, steel and aluminium). On the other hand, the imports of cork and wood manufactures (excluding furniture) and paper products fell by 28.7 percent and 11.8 percent respectively. Furthermore, iron and steel imports and rubber and articles thereof fell by 6.0 percent and 15.7 percent respectively, while non-ferrous metals recorded a significant increase of 31.9 percent

The importation of **miscellaneous manufactured articles** recorded a slight increase of 2.2 percent, moving from a value of CI\$114.2 million in 2015 to CI\$116.7 million in 2016. This was largely attributed to the upswing in imports of furniture and parts thereof (20.9%), articles of apparel and clothing accessories (18.9%) and sanitary, plumbing, heating and lighting fixtures which grew by 17.3 percent. Imports of photographic apparatus equipment and supplies and optical goods and watches and clocks contracted by 17.2 percent to CI\$14.0 million compared to CI\$17.0 million recorded in 2015. This was driven by the fall in imports of cameras, videos, lenses and travel clocks and watches. Additionally, the imports of miscellaneous manufactured articles n.e.s fell by 7.5 percent to CI\$42.3 million from CI\$45.7 million in 2015. This reflects the drop in the imports of work of arts and collectors pieces, other jewellery of precious metal and office supplies of metal. However, imports of reading materials and articles of plastics increased.

The sharp decline of 14.3 percent in the value of **minerals**, **fuels**, **lubricants** and **related materials** weakened the overall growth rate of imports for 2016. For 2016, the total imports of this category amounted to CI\$85.4 million, compared to CI\$99.7 million in 2015. This was largely due to the fall in both price and quantity of petroleum products. On average, the price of petroleum products (excluding natural gas) in the international



market fell by 13.8 percent, while the quantity of fuel imports fell by 1.7 percent. Both the price per unit and quantity for diesel, gasoline and aviation fuel fell.

In 2016, the sharp decline in the value of imports of non-monetary gold by 24.0 percent accounted for a large portion of the 5.9 percent drop in **commodities and transactions n.e.c.**. For 2016, the total value of non-monetary gold imports was CI\$53.4 million compared to CI\$70.3 million recorded in 2015. Imports via the postal services grew by 22.7 percent along with imports via courier and airport terminals which grew by 9.5 percent. On the other hand, imports of special items not classified elsewhere fell by 8.2 percent.

## Imports by country of origin

The United States (US) continues to be the dominant trading partner of the Cayman Islands. In 2016, its contribution increased marginally from 80.2 percent of total imports valued at CI\$695.6 million from 84.4 percent valued at CI\$666.6 million in 2015. This slight increase is traced mainly to machinery and transport equipment, crude materials and beverages. Imports from Japan grew substantially by over 100 percent, arising from imports in machinery and transport equipment. Imports from South Korea and Curacao fell by 34.4 percent, and 13.2 percent respectively.

## Imports by broad economic category

Analysis of imports by broad economic categories (BEC) of end use reveals that most of the categories increased, except for consumption goods and motor spirit.

The capital goods category (see Table 2.7b) saw an increase of 3.7 percent to reach CI\$94.5 millilon, largely on account of the increase in imports of construction and mining machinery, office machines and automatic data processing machines, general industrial machinery and equipment and parts.

Intermediate goods grew by 5.9 percent from CI\$153.2 million in 2015 to CI\$162.3 million in 2016. This reflects the increase in food and beverages primary mainly for industry; industrial supplies not elsewhere classified such as household paint, cement, steel, iron and aluminum structures, pvc tubing and articles of plastic; and parts and accessories for capital goods and transport and equipment.

Consumption goods fell slightly by 0.1 percent to CI\$392.3 million, with food and beverages for household consumption falling by 11.7 percent and consumer goods not elsewhere classified (mainly gold coins) declining by 3.8 percent.

In 2016, the total value of passenger motor vehicles recorded a sharp growth of 47.9 percent and stood at CI\$63.5 million. In contrast, a decline of 15.3 percent was recorded in



motor spirits, to total CI\$80.1 million, on account of the fall in both fuel prices in the international market, and the quantity of imported fuel.

## 3.3 Exports

In 2016, merchandise exports contracted by 10.4 percent to CI\$73.6 million compared to the CI\$82.2 million recorded in 2015, dominated by re-exports. This decline is traced to the "commodities and transactions not elsewhere classified" category which accounted for 93.6 percent of recorded exports. The exports of gold and gold bullion comprised CI\$58.2 million of total exports, followed by the exports of personal items.

# **CHART 3: IMPORTS BY REGION OF ORIGIN, 2016**


