

CAYMAN ECONOMIC REPORT: MARCH 2006 INFLATION (Released June 7, 2006)

Consumer Prices Down 1.6 Percent in the First Quarter of 2006

The Consumer Price Index (CPI) stood at 139.6 in March 2006, down by 1.6 percent in comparison to March 2005, on account mainly of drops in the price indices for housing, education and medical services and household equipment.



The first quarter CPI also fell by 1.6 percent compared to the December 2005 level as a result of declines in the price indices for housing, education and medical services, household equipment, personal goods and services, alcohol and tobacco.

Annual changes

The following items contributed in pulling down the CPI in March this year from the level a year ago:

• **Housing:** the overall housing price index, which accounts for 1/3 of the entire CPI basket, settled at 138.1. This is 8.1% below the level in March 2005 on account mainly of falling rental prices. Rents in all 3 reference areas fell as follows: Prospect, 20%; West Bay 13.5%; and South Sound, 13%. On average, rental prices collected in these areas fell by approximately CI\$365 over the one year review period. Imputed rent of owner-occupied dwellings also fell by 15.7%.



On the other hand, the price index for utilities rose by 13.3% in March 2006 compared to March 2005. Electricity prices increased by 18.9%, to reach CI\$55.58 per 200 kilowatts hours in a month. Similarly, the price of cooking gas went up by 22.9%, from CI\$61.00 to CI\$75.00 per 100 lbs cylinder. These trends could be attributed to the direct impact of international oil prices on these items.

- **Household equipment**: this index fell by 4.7% and was recorded at 128. The decline originated mainly from a 4.0% drop in the price of floor coverings and a 9.9% dip in china, glass and ironmongery prices.
- Educational and medical services: average prices of these services inched down by 0.5%, on account of a 1.1%-drop in the education price index.

Average fees for tertiary education slid by 22.4% although school fees were up by 2.2% and books and newspapers also rose by 14.1%

The price index for medical care was marginally up by 0.3% as the average fee for treatment in hospitals and clinics including medical laboratory tests fell by 1.3% in March 2006 compared to a year ago. However, drugs or medicines purchased from private stores rose by 10.4%.

Meanwhile, the price indices for the following household expenditures remained on the uptrend, albeit at varying rates:

- **Personal goods and services:** the price index inched up by 3.4% in the first quarter, pulled up mainly by the 13.2% average increase in holiday-related prices (airline tickets, travel and accommodation). Personal services which include hairdressing and beauty parlours, also rose by 6.2 percent.
- **Alcohol and tobacco**: the price index moved up by 3.8% in the first quarter, primarily due to an increase in the average price of alcoholic drinks.
- **Food:** the average price of the reference food items went up by 2.7% compared to a year ago. Among the significant price changes were those for rice (7.6%), mutton & lamb (29.7%), pork (5.8%), bacon & ham (11.4%), processed fish & fish products (18.4%), and eggs (13.6%)
- **Transportation and communication**: the price index rose by 2.4% in March 2006 compared to a year ago, as prices of household vehicles moved up by 6.8%. In contrast, the price for communication services fell by 23.9%.
- **Clothing:** this index was up slightly by 0.8% as it settled at 106.9 compared to 106.1 for the first quarter of 2005.



Quarterly changes

The overall decline of 1.6% in the CPI as compared to the December 2005 CPI can be traced to the following indices:

- **Housing:** the index of this category fell anew by 4.1%. Prices of utilities were down by 6.0 percent while rental prices (together with housing maintenance and insurance) also posted a 3.7%-average decline. Electricity prices for 200 kilowatt hours stood at CI\$55.58 per month in first quarter of 2006, from CI\$59.78 in the last quarter of 2005. Rent in the West Bay and Prospect area declined, compared to the last quarter of 2005.
- **Personal goods and services:** this registered a 3.9% decline emanating from a 10.3% downward adjustment in the average price of domestic services and a 34.2%- decline in home entertainment goods.
- Education and medical services: average prices for this basket fell by 3.0% on account of similar declines in both medical and educational services. Fees for doctors, dentists and opticians slid by 4.1% from a quarter ago; however, medicine prices rose by 4.0%. School fees registered a 3.7%-decline.
- **Household equipment:** the price index slipped by 1.1% as a result of an 8.8%-drop in china, glass and ironmongery prices. This offset the significant increases posted for household appliances (7.7%), furniture and floor coverings (5.0%).

The index for alcohol and tobacco also fell (1.4%) in March 2006 compared to a quarter ago.

However, upward movements were recorded for food (0.9%), clothing (4.0%), and transportation and communication (4.8%). The latter resulted from a 7.0%-increase in the price of household vehicles, in addition to a 1.1%-increase in taxis and hire car fares.

Additional notes

The negative inflation (or deflation) recorded in March 2006 follows the deflation recorded in December 2005 (-0.3%). Both episodes mark the only episodes of negative year-on-year inflation rates in the Cayman Islands since the CPI was continuously measured starting in 1994. (Year-on-year inflation refers to the measurement of the inflation rate by comparing the CPI of the current quarter to the same quarter a year ago). (See also Table 1 and Figures 2 and 3).



NOTES ON THE INDEX COMPILATION

1. For one month in each quarter of the year namely March, June, September and December, staffs of the Economics and Statistics Office collect data on prices of more than 500 different items on which consumers spend their money, from over 100 different shops and other outlets in Grand Cayman. Every kind of spending is included, from weekly supermarket trips, school lunches, rental payments and insurance to the prices of cars and bicycles. In total about 1,800 prices are collected each quarter.

2. The items have been assigned weights depending upon their importance in the total pattern of consumer spending based on the 1990/91 Household Income and Expenditure survey. The item weights combined with the prices are then compiled to arrive at the published index.




Figure 1-1. Cayman Islands CPI Inflation Rates for Quarter 1, 2000-2006

Figure 1-2. Cayman Islands CPI Inflation Rates for Quarter 1, 2000-2006






Figure 1-3. Cayman Islands CPI Inflation Rates for Quarter 1, 2000-2006





Figure 2. Cayman Islands CPI and Inflation Quarter 1, 2000-2006








Figure 3. Cayman IslandsCPI and Inflation Rates 2000-2006
